

During 2014 The Exodus Road supported 27 undercover operatives throughout Southeast Asia and South Asia. 55 Pieces of gear were provided to field teams. 400 plus locations were investigated for suspected trafficking. 52 victims rescues took place and 28 arrests of traffickers were made. 70 recovered victims were placed in aftercare and The Exodus Road continues to monitor their progress in recovery, assisting when requested. The Exodus Road also conducted the training of 250 national practitioners and leaders in fighting human trafficking.
