The Exodus Road fuels this work by providing covert gear, operational funding, training, and networking support.

(Revenue \$) During 2015, The Exodus Road undercover operatives investigated over 400 locations suspected of human trafficking activities in 3 regions: SE Asia, South Asia and North America. 24 team members were volunteer operatives who deployed overseas for short periods, 19 team members were national staff in SE Asia and India. The Exodus Road program TraffickWatch, which operates in the United States, vetted and trained 65 volunteers who participate in nights of surveillance to collect tips, which are submitted to local authorities after being processed through a unique data system. The Exodus Road trained 360 nationals in counter trafficking strategies. In 2015 the Exodus Road contributed to the rescue of 356 human trafficking survivors and the arrests of 94 traffickers while working directly with local law enforcement.
